





**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village of Vernon Hills hosts the July 4<sup>th</sup> parade and evening entertainment in the park; and

**WHEREAS**, the Village works with numerous entertainers to procure entertainment for the parade and evening events; and

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2022-070


