ORDINANCE 2023-003**

**AN ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2022 TO PAY THE PRINCIPAL AND INTEREST ON \$5,630,000 GENERAL OBLIGATION BONDS, SERIES 2014, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS**

**WHEREAS**, the President and Board of Trustees (the "*Corporate Authorities*") of the Village of Vernon Hills, Lake County, Illinois (the "*Village*"), by an ordinance adopted on the 2<sup>nd</sup> day of December, 2014 (the "*Ordinance*"), did provide for the issue of \$5,630,000 General Obligation Bonds, Series 2014 (the "*Bonds*"), and the levy of a direct annual tax to pay the principal of and interest on the Bonds; and

**WHEREAS**, funds from a lawfully available source not derived from any borrowing (the "*Lawfully Available Funds*") are available for the purpose of paying principal and interest on the bonds up to and including March 30, 2024; and

**WHEREAS**, the Lawfully Available Funds have been deposited in the Bond Fund (as defined in the Ordinance) in an amount sufficient to pay debt service on all the Bonds up to and including March 30, 2024; and

**WHEREAS**, it is necessary and in the best interests of the Village that the tax heretofore levied for the year 2022 to pay the principal of and interest on the Bonds be abated;

**NOW THEREFORE BE IT ORDAINED** by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, as follows:

**Section 1: Abatement of Tax.** The tax heretofore levied for the year 2022 in the Ordinance is hereby abated in its entirety.

**Section 2: Filing of Ordinance.** Forthwith upon the adoption of this ordinance, the Secretary of the Corporate Authorities shall file a certified copy hereof with the County Clerk of The County of Lake, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2022 in accordance with the provisions hereof.

**Section 3: Effective Date.** This ordinance shall be in full force and effect forthwith upon its passage by the Corporate Authorities and signing and approval by the President.

**Section 4: Ordinance Number.** This ordinance shall be known as Ordinance Number 2023-003.


