**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO UPTOWN  
MOTORS FOR THE PURCHASE OF ONE (1) 2022 FORD EDGE SEL AWD FOR AN  
AMOUNT OF \$41,099.00**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, funds are delineated in FY2023 budget account (2103030-540020) for vehicle purchases; and

**WHEREAS**, the Police Department is seeking a new vehicle for Administration as a result of shifting their current Ford Explorer to Investigations; and

**WHEREAS**, the Police Department is seeking to purchase one (1) 2022 Ford Edge SEL AWD vehicle; and

**WHEREAS**, said vehicle is available for the lowest price from Uptown Motors out of Milwaukee, WI for an amount of \$41,099.00; and

**WHEREAS**, Uptown Motors, 2111 North Mayfair Road, Milwaukee, WI, 53226 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities; and

**WHEREAS**, all purchases over \$25,000 require Board of Trustee approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Uptown Motors to commit the Village to purchase one (1) 2022 Ford Edge SEL AWD vehicle in the amount of \$41,099.00; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Uptown Motors in the amount of \$41,099.00; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance Number 2023-020.




