ORDINANCE 2023-034**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO SUTTON FORD FOR THE PURCHASE OF THREE (3) 2023 FORD UTILITY INTERCEPTORS IN AN AMOUNT NOT TO EXCEED \$130,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, staff delineated funds within FY2024 budget account (2103030-540020) for the purchase of three (3) police replacement vehicles; and

**WHEREAS**, said replacement vehicles will include three (3) 2023 Ford Utility Interceptors; and

**WHEREAS**, Staff desires to purchase said vehicles from Sutton Ford for an amount not to exceed \$130,000; and

**WHEREAS**, Sutton Ford, 21315 Central Ave., Matteson, IL 60443 is an authorized Ford dealership that has been selected through a competitive bidding process to provide motor vehicles to municipalities participating in the State of Illinois Joint Purchasing Cooperative Contract #23-4931SP at the rate specified in the bid (contract); and

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Sutton Ford to commit the Village to purchase three (3) 2023 Ford Utility Interceptors in an amount not to exceed \$130,000; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Sutton Ford in an amount not to exceed \$130,000 for the purchase of three (3) 2023 Ford Utility Interceptors; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as ORDINANCE NUMBER 2023-034.


