

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-029**

AN ORDINANCE AMENDING ORDINANCE 2022-047 AUTHORIZING AN INCREASE IN EXPENDITURES TO PETROLEUM TRADERS CORP. TO FURNISH & DELIVER FUEL FROM A NOT TO EXCEED AMOUNT OF \$273,000 TO A NOT TO EXCEED AMOUNT OF \$298,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village purchases fuel for use in its fleet from a fuel supplier; and

WHEREAS, Community School District #128, Hawthorn School District #73, Cook Memorial Library, Countryside Fire Protection District, Vernon Hills Park District and the MEG Unit utilize the Village's supply of fuel; and each user reimburses the Village the amount the Village pays plus an \$.08 surcharge per gallon of usage each month; and

WHEREAS, Ordinance 2022-047 authorized the Village to enter into a two-year contract with Petroleum Traders Corp. for the purchase of fuel with a not to exceed amount of \$273,000 within the 2023 Fiscal Year; and

WHEREAS, due to the prolonged high fuel prices, an additional \$25,000 is needed to cover the cost of fuel that will be purchased for the month of April; and

WHEREAS, \$25,000 is available within the current Public Works FY2023 budget for said purchase.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to increase FY2023 Purchase Order #098 to Petroleum Traders Corp. from \$273,000 to \$298,000, and to make payments to Petroleum Traders Corp. in an amount not to exceed \$298,000 within Fiscal Year 2023.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2023-029.






