

**VILLAGE OF VERNON HILLS  
ORDINANCE 2023-042**

**AN ORDINANCE AMENDING ORDINANCE 2023-021 AUTHORIZING THE VILLAGE TO EXECUTE A CONTRACT CHANGE ORDER WITH CORRECTIVE ASPHALT MATERIALS, LLC (CAM) TO APPLY RECLAMITE MALTENE BASED REJUVENATING AGENT TO VILLAGE STREETS FOR AN AMOUNT NOT TO EXCEED \$74,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village participated in the 2021 Municipal Partnering Initiative (MPI) Joint Bid for Pavement Rejuvenation Reclamite Preservation Sealing; and

**WHEREAS**, said bid was awarded to Corrective Asphalt Materials, LLC (CAM) for a multi-year renewable contract from 2021 through 2023; and

**WHEREAS**, Ordinance 2023-021 authorized the Village Manager to execute a contract for the 2023 program with Corrective Asphalt Materials, LLC (CAM) to perform Reclamite preservation sealing of Village streets for an amount not to exceed \$68,000 based on a price per square yard of \$.94; and

**WHEREAS**, CAM has incurred high inflation costs over the past year and in an effort to off-set costs, they are proposing to increase the price per square yard from \$.93 to \$1.03; and

**WHEREAS**, Staff budgeted \$74,000 within the proposed FY2024 budget account (0209059-550050) for contractual Reclamite preservation sealing of Village streets and can accommodate the proposed price increase; and

**WHEREAS**, Staff seeks approval to authorize the Village Manager to execute a contract change order with CAM for \$6,000 bringing the total contract amount not to exceed \$74,000.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents for a contract change order to the agreement with Corrective Asphalt Materials, LLC for an amount not to exceed \$74,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to Corrective Asphalt Materials, LLC for an amount not to exceed \$74,000.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-042.






