ORDINANCE 2023-045**

AN ORDINANCE AUTHORIZING THE VILLAGE TO EXECUTE A CONTRACT WITH MONROE TRUCK EQUIPMENT CO. TO PURCHASE ONE (1) 2023 KM INTERNATIONAL 4000TEDD ASPHALT HOT BOX FOR AN AMOUNT NOT TO EXCEED \$35,245

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff delineated \$40,000 within the proposed FY2024 budget account (2102040-540030) for the purchase of one asphalt hot box for pavement patching and potholing; and

WHEREAS, Monroe Truck Equipment Co. is an authorized KM International dealership that has been selected through a competitive bidding process to provide equipment to municipalities participating in the Sourcewell Cooperative Purchasing Agreement: Contract #080521-KMI at the rate specified in the bid (contract); and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Monroe Truck Equipment Co. to purchase one (1) 2023 KM International 4000TEDD Asphalt Hot Box for an amount not to exceed \$35,245.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Monroe Truck Equipment Co. to purchase one (1) 2023 KM International 4000TEDD Asphalt Hot Box for an amount not to exceed \$35,245.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is hereby authorized to process a purchase order and make payment to Monroe Truck Equipment Co. for an amount not to exceed \$35,245.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law.

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as Ordinance Number 2023-045.


