ORDINANCE 2023-046**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO TYLER TECHNOLOGIES FOR THE PURCHASE OF MUNIS MAINTENANCE SERVICES FOR FISCAL YEAR 2024 IN AN AMOUNT NOT TO EXCEED \$57,900**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village currently uses Tyler Technologies' Munis as its financial software to record revenue and expenditure transactions, issue payments to its vendors, and issue and collect permits; and

**WHEREAS**, the Village has determined that Tyler Technologies' Munis software currently meets the needs of the Village and that it is cost effective to renew the financial software service for the fiscal year 2024; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase maintenance services for Fiscal Year 2024 from Tyler Technologies in an amount not to exceed \$57,900.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Tyler Technologies in an amount not to exceed \$57,900 for Fiscal Year 2024 maintenance services.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-046.




