**AN ORDINANCE ADJUSTING THE CURRENT SENIOR STAFF SALARIES IN  
THE VILLAGE OF VERNON HILLS MANAGEMENT PAY SCHEDULE**

**WHEREAS**, the Village of Vernon Hills Management Pay Schedule (*“Pay Schedule”*) lists the corresponding salary ranges and salaries that are authorized for Senior Staff; and

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-039.






