ORDINANCE 2023-050**

**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO TI TRAINING LE LLC FOR THE PURCHASE OF A NEW SCENARIO BASED DECISION MAKING SIMULATOR IN AN AMOUNT NOT TO EXCEED \$57,050**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, this purchase is necessary because the current shared scenario based decision making simulator is due for replacement, due to costly repairs and maintenance, and the Police Department continues to receive monies from local law enforcement partners to help cover this expense; and

**WHEREAS**, Staff budgeted \$12,000 within the approved Fiscal Year 2024 budget account (0103035-520990) for the Village’s contribution towards the purchase of a new scenario based decision making simulator that is a shared resource among five other local law enforcement partners; and

**WHEREAS**, the Village continues to be the lead agency which collects and distributes all monies on behalf of the continued local law enforcement partnership for the purpose of a shared training simulator. The Village maintains a MILO Firearms Judgmental System account (01-240856) which holds monies to fund mutually agreeable training components/opportunities; and

**WHEREAS**, the Village will incur an actual cost of \$9,975 within the approved Fiscal Year 2024 budget account (0103035-520990) for the Village’s contribution towards the purchase of a new scenario based decision making simulator and the remaining balance of \$47,075 will be paid by the shared monies collected from the other local law enforcement partners (01-240856); and

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase one (1) simulator, training, and recoil kits from Ti Training LE LLC at a price not to exceed \$57,050; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Ti Training LE LLC in an amount not to exceed \$57,050 for the purchase of one (1) simulator, training, and recoil kits; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance Number 2023-050.




