

**VILLAGE OF VERNON HILLS  
ORDINANCE 2023-048**

**AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO FLECK'S LANDSCAPING TO PERFORM GENERAL MOWING OF VILLAGE PROPERTY FOR AN AMOUNT NOT TO EXCEED \$100,630**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village is responsible for maintaining Village-owned properties and various Village rights of ways (ROW's); including lawn care and maintenance; and

**WHEREAS**, to do so efficiently and effectively, the Village contracts general mowing services for 40 locations throughout the Village; and

**WHEREAS**, Flecks Landscaping was awarded the 2021-2023 multi-year contract for General Mowing of Village Property (Ordinance 2021-039) with a base price of \$85,630 per year for all three years; and

**WHEREAS**, the Village has budgeted funds within the FY2024 budget account (0102047-520600) for general contractual mowing, and

**WHEREAS**, a contingency of \$15,000 will be available for general mowing services beyond the base bid for extreme weather conditions; and

**WHEREAS**, Staff seeks approval to authorize the Finance Director to execute payments to Fleck's Landscaping for an amount not to exceed \$100,630 for general mowing services.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to execute payments to Flecks Landscaping for an amount not to exceed \$100,630 within the 2024 Fiscal Year for the General Mowing of Village Property.


**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-048.




