

RESOLUTION 2011-036

A RESOLUTION GRANTING APPROVAL TO OPERATE AN OUTDOOR SPECIAL EVENT FOR WINDY CITY AMUSEMENTS LOCATED AT 122 HAWTHORN CENTER

WHEREAS, Tony Salerno, representing Windy City Amusements on behalf of Westfield Hawthorn Mall, 122 Hawthorn Center has submitted an Outdoor Establishment permit application and plan for authorization to operate a special event; and

WHEREAS, the Board of Trustees of the Village of Vernon Hills, on August 15, 2000, approved Ordinance 2000-61 requiring business owners to seek approval from the Board of Trustees prior to operating an Outdoor Establishment; and

WHEREAS, the Board of Trustees, at their meeting on March 15, 2011 having reviewed and considered the proposed outdoor special event, including the letter from Westfield Hawthorn granting permission for the special event, found that it sufficiently complies with the operational requirements and standards of Ordinance 2000-61 and which, in its judgment, would justify recommending approval of an Outdoor Establishment Permit.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, that the Village of Vernon Hills will allow Windy City Amusements to operate an outdoor special event, conditioned upon:

1. Permission is granted to conduct the event from May 19, 2011 to May 22, 2011. Permitted hours of operation will be: Thursday, May 19, 2011 from 6:00 PM to 10:00 PM; Friday, May 20, 2011 from 6:00 PM to 10:00 PM; Saturday, May 21, 2011 from 1:00 PM to 10:00 PM; and Sunday, May 22, 2010 from 1:00 PM to 10:00 PM.
2. The Village reserves the right to close off portions of Ring Road for the purpose of creating a pedestrian crossing.
3. Windy City Amusements is required to submit a list of all employees working at the carnival to the Vernon Hills Police Department at least ten (10) days in advance of the event.
4. Windy City Amusements is required to hire two (2) off duty Vernon Hills' police officers to be on site during the operating hours of the carnival. Windy City Amusements shall be responsible to pay the cost of the officers at a rate determined by the village.
5. Garbage receptacles shall be provided and the general vicinity shall be cleaned immediately following each day of the event.


