

RESOLUTION 2011-040

A RESOLUTION AMENDING RESOLUTION 2010-44 AUTHORIZING AN INCREASE TO PURCHASE ORDER 2011-012 TO STEINER ELECTRIC COMPANY FOR THE PURCHASE OF ELECTRICAL SUPPLIES FOR THE PUBLIC WORKS BUILDING IN THE AMOUNT OF \$1,400

WHEREAS, Steiner Electric Company is a sole source or a source determined by the Village Manager to be beneficial to the Village as supplier of electrical supplies and parts purchased for general building maintenance and street lighting work; and

WHEREAS, the Village Board approved the 2010/2011 budget which delineated electrical supplies in the following accounts; and

WHEREAS, a total of \$13,100 was budgeted in the Public Works Building & Grounds Maintenance Supplies account 0102046-530070; and

WHEREAS, purchase order 2011-012 was issued to Steiner Electric Company for the purchase of electrical supplies for the Public Works Building in the amount of \$2000 from account 0102046-530070; and

WHEREAS, the amount of electrical supply purchases made for the Public Works Building has exceeded the \$2000; therefore, requiring an increase to the purchase order; and

WHEREAS, the funds to increase purchase order 2011-012 are available in the Public Works Building & Maintenance Supplies account 0102046-530070.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

THAT the Finance Director is authorized to increase purchase order 2011-012 to Steiner Electric Company in the amount of \$1,400; and the Village Manager is authorized to execute payments.


