

**VILLAGE OF VERNON HILLS  
ORDINANCE 2023-081**

**AN ORDINANCE AMENDING ORDINANCE 2023-030 AUTHORIZING A CHANGE-ORDER FOR PATRIOT PAVEMENT, INC. TO PERFORM CRACK SEALING & SEAL COATING WORK, AND TO INCREASE EXPENDITURES FROM A NOT TO EXCEED AMOUNT OF \$25,000 TO A NOT TO EXCEED AMOUNT OF \$38,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village is responsible for maintaining all Village-owned public streets & parking lots; and

**WHEREAS**, to do so efficiently and effectively, the Village contracts out crack sealing and seal coating services to be performed on various public streets and parking lots on an annual or as-need basis; and

**WHEREAS**, Ordinance 2023-030 awarded the Village’s 2023 Crack Sealing Program to Patriot Pavement, Inc. for an amount not to exceed \$25,000; and

**WHEREAS**, Staff delineated funds within the FY2024 budget account (0209059-550050) to replace the Vernon Hills Golf Course (Muni) parking lot as part of the 2023 Parking Lot Rehabilitation Program; and

**WHEREAS**, the Village received proposals to replace all desired parking lots for an amount above what was budgeted; and

**WHEREAS**, Staff is choosing to seal coat the Muni parking lot and cart paths in lieu of repaving to stay within budget; and

**WHEREAS**, Patriot Pavement, Inc. specializes in both seal coating and crack sealing services, and provided the Village with a proposal to perform both for an amount not to exceed \$38,000 (\$25,000 crack sealing, \$13,000 seal coating).

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents with Patriot Pavement, Inc. for the 2023 Crack Sealing Program and seal coating of the Vernon Hills Golf Course (Muni) parking lot and cart paths for an amount not to exceed \$38,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to increase FY2024 Purchase Order #034 from \$25,000 to

\$38,000; and to make payment to Patriot Pavement, Inc. for an amount not to exceed \$38,000.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-081.






