**AN ORDINANCE AUTHORIZING THE PURCHASE OF FIFTY-TWO (52) GLOCK MODEL 45 GEN 5, 9MM PISTOLS (MOS), SIX (6) GLOCK MODEL 43X 9MM PISTOLS AND OPTICS FROM KIESLER POLICE SUPPLY IN AN AMOUNT NOT TO EXCEED \$46,144 LESS A TRADE-IN CREDIT OF \$18,200 FOR A NET AMOUNT DUE NOT TO EXCEED \$27,944**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Police Department equips all of its sworn officers with duty pistols; and

**WHEREAS**, the duty pistols presently issued to officers are equipped with traditional steel sights; and

**WHEREAS**, a committee of Police Department personnel has evaluated different police firearms and have selected the Glock Model 45 GEN 5, 9mm pistol with MOS capabilities for future patrol use and the Glock Model 43X, 9mm pistol with MOS capabilities for administrative use; and

**WHEREAS**, a committee of Police Department personnel has evaluated different police firearm pistol optics and have selected the Holosun Self Charging Sight (SCS) for future use with the Glock G45 and the Holosun LE 507 for future use with the Glock 43X; and

**WHEREAS**, Kiesler Police Supply, 2802 Sable Mill Road, Jeffersonville, IN 47130 is an authorized Glock Law Enforcement Dealer; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustees approval.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase fifty-eight (58) Glock pistols and fifty-eight (58) optics/accessories at a net price not to exceed \$27,944 from Account #0103035-530180.

**SECTION 2: AUTHORIZATION OF DISPOSAL & RELEASE OF PAYMENT:** The Chief of Police is hereby authorized to dispose of 59 pistols, owned department weapons, by trading them in for credit value of \$18,200 to offset the costs of the new Glock pistols and optics/accessories. The Finance Director is hereby authorized to make payment to Kiesler Police Supply in an amount not to exceed \$27,944 per the attached quote in Exhibit A.

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance Number 2023- 079.


