

**VILLAGE OF VERNON HILLS  
ORDINANCE 2023-076**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE (1) 2024 FORD F450 CHASSIS CAB TRUCK FROM SUTTON FORD FOR AN AMOUNT NOT TO EXCEED \$55,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Staff has delineated funds within FY2024 budget account (2102040-540030) for the purchase of one (1) 2024 Ford F450 Chassis Cab Truck; and

**WHEREAS**, said vehicle will be purchased through Sutton Ford, 21315 Central Ave., Matteson, IL 60443 who is an authorized Ford dealership that has been selected to provide motor vehicles to municipalities participating in the Northwest Municipal Conference Suburban Purchasing Cooperative at competitive pricing; and

**WHEREAS**, Staff seeks approval to authorize the Village Manager to execute a contract with Sutton Ford to purchase one (1) 2024 Ford F450 Chassis Cab Truck for an amount not to exceed \$55,000.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Sutton Ford to commit the Village to purchase one (1) 2024 Ford F450 Chassis Cab truck in an amount not to exceed \$55,000.

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Sutton Ford in the amount of \$55,000.

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law.

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as ORDINANCE NUMBER 2023-076.




