

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-092**

AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO EXECUTE A CONTRACT WITH ADVANCED TREE CARE FOR PARKWAY TREE TRIMMING FOR AN AMOUNT NOT TO EXCEED \$75,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, \$75,000 is delineated in Fiscal Year 2024 budget account (0102047-520600) for Contractual Parkway Tree Trimming; and

WHEREAS, the Village received four (4) sealed bids on August 29, 2023 for Parkway Tree Trimming 2023-2026; at which time it was publicly opened; and

WHEREAS, the lowest qualifying bid was received by Advanced Tree Care; and

WHEREAS, said contract will be a one year contract with the option to renew an for additional two years from 2023-2026; and

WHEREAS, the contractor shall perform tree trimming within Area 1 of the contract in year 1 (2023-24). This area includes approximately 1,200 trees within the Deerpath Subdivision; as well as on Creekside and Sullivan Drives; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Advanced Tree Care to perform parkway tree trimming.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Advanced Tree Care for Parkway Tree Trimming.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Advanced Tree Care for an amount not to exceed \$75,000 within Fiscal Year 2024.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.




