**AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF VILLAGE WIDE
COMPUTER WORKSTATION LIFECYCLE REPLACEMENTS FROM AMAZON BUSINESS
FOR AN AMOUNT NOT TO EXCEED \$27,600.00**

WHEREAS, the current computers that need replacement have reached the end of their life expectancy, and the Village has a replacement plan in which the oldest computers are replaced and updated; and

WHEREAS, Village staff access several software packages in their daily operations, including MUNIS/Enterprise ERP, Tyler Technologies Public Safety suite, GIS, InTime Schedule, Microsoft Office, and other critical software packages; and

WHEREAS, the Village budgeted money for FY24 for the established lifecycle replacements that is sufficient to cover the costs of this purchase; and

WHEREAS, this purchase meets the Village bidding requirements because Amazon Business provided the lowest cost and is capable of providing these computers.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

That the Village Manager is authorized to direct the staff to purchase the necessary computers, not to exceed \$27,600.00, from Amazon Business using established account 0101004-540050.




