

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-102**

AN ORDINANCE AMENDING ORDINANCE 2023-058 AUTHORIZING AN INCREASE OF EXPENDITURES TO CHICAGOLAND PAVING CONTRACTORS, INC. FOR THE 2023 BITUMINOUS PAVEMENT PATCHING PROGRAM WITHIN THE FY2024 BUDGET BY \$9,975.07

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's); including public streets; and

WHEREAS, to do so efficiently and effectively, the Village contracts asphalt patching of damaged sections of pavement on various public streets on an annual basis; and

WHEREAS, Ordinance 2023-019 awarded the 2023 Bituminous Pavement Patching Program to Chicagoland Paving Contractors, Inc. for a not to exceed amount of \$120,000; and

WHEREAS, Ordinance 2023-058 authorized a \$15,000 increase in expenditures to Chicagoland Paving Contractors, Inc. to perform additional patching; and

WHEREAS, this ordinance, 2023-102, authorizes an additional \$9,975.07 increase in expenditures to Chicagoland Paving Contractors, Inc. to perform necessary patching on Annapolis Dr.; and

WHEREAS, Staff seeks approval to increase expenditures to Chicagoland Paving Contractors, Inc. for the 2023 Bituminous Pavement Patching Program by an additional \$9,975.07.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required contract documents for the 2023 Bituminous Pavement Patching Program with Chicagoland Paving Contractors, Inc. for a price not to exceed \$144,975.07.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to increase FY2024 Purchase Order #024 to Chicagoland Paving Contractors, Inc. from \$135,000 to \$144,975.07 and to make payment to Chicagoland Paving Contractors, Inc. in an amount not to exceed \$144,975.07.


