

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-103**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF LED STREET LIGHT
FIXTURES FROM STEINER ELECTRIC FOR AN AMOUNT NOT TO EXCEED
\$60,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village Board approved the FY2024 budget which delineates funds within budget account (0209087-550050) for the purchase of LED Street Light Fixtures; and

WHEREAS, Staff sought pricing through Steiner Electric for the purchase of said fixtures and received a quote for \$58,806.95 minus freight; and

WHEREAS, Steiner Electric Company is a beneficial local source to the Village as a supplier of electrical supplies and misc. parts purchased for general building maintenance and street lighting work; and

WHEREAS, said fixtures will be installed in Continental Executive Parke, New Century Town subdivision, and the Village Hall, Communications Center and Muni Golf Course parking lots; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is authorized to execute payments to Steiner Electric Company for the purchase of LED Street Light Fixtures for Continental Executive Parke, New Century Town subdivision, and the Village Hall, Communications Center and Muni Golf Course parking lots for an amount not to exceed \$60,000.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2023-103.




