

**VILLAGE OF VERNON HILLS  
ORDINANCE 2023-108**

**AN ORDINANCE AUTHORIZING THE VILLAGE TO WAIVE THE BIDDING PROCESS AND ENTER INTO CONTRACTS WITH PYROTECNICO FIREWORKS, INC. FOR THE JULY 4<sup>TH</sup> AND VERNON HILLS DAYS FIREWORKS IN AN AMOUNT NOT TO EXCEED \$48,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village of Vernon Hills provides fireworks on July 4<sup>th</sup> and during Vernon Hills Days; and

**WHEREAS**, the Village requests to waive the bidding process and contract with Pyrotecnico Fireworks, Inc. as a sole source; and

**WHEREAS**, Pyrotecnico Fireworks, Inc. will provide contracts for the July 4<sup>th</sup> fireworks in the amount of \$32,000 and the Vernon Hills Days fireworks in the amount of \$15,750; and

**WHEREAS**, expenditures over \$25,000 require Board of Trustee approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to purchase fireworks at a price not to exceed \$48,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make two payment to Pyrotecnico Fireworks, Inc. in an amount not to exceed \$48,000 total per the attached contracts in Exhibit A.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2023-108


