

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-115**

**AN ORDINANCE AMENDING CHAPTER 25, COMPREHENSIVE FEES AND PENALTIES,
TO INSERT DONATION BOX REGISTRATION FEE AND REFLECT ORGANIZATION OF
CHAPTER 10, LICENSES, PERMITS, AND BUSINESS REGULATIONS, OF THE VERNON
HILLS VILLAGE CODE**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (Village) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village regularly reviews and updated the Municipal Code to ensure protection of the health, safety, and welfare of the public, protection of property values and neighborhood integrity, avoiding the creation of nuisances, and insuring the continued safe and sanitary use of property within the Village; and

WHEREAS, the Village has determined that it is necessary to amend Chapter 10, Article XI of the Code that addresses the placement, maintenance, and permit process relating to Donation Boxes within the Village; and

WHEREAS, the amendment to Chapter 10, Article XI, references the establishment of fees and penalties in Chapter 25 relating to donation boxes; and

WHEREAS, the insertion of said fees and penalties relating to donation boxes requires amendments to the fee table in Chapter 25, Section 25-10, which lists all fees referenced in Chapter 10, Licenses, Permits, and Miscellaneous Business Regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION 1: INCORPORATION – Each “Whereas” paragraph set forth above is incorporated by reference into this Section 1 and made a part hereof as material and operative provisions of this Ordinance.

SECTION 2: CODE AMENDMENT – Chapter 25, Comprehensive Fees and Penalties, Section 25-10, “Licenses, Permits and Miscellaneous Business Regulations – Chapter 10” is hereby deleted and amended to read in its entirety as follows:

Section 25-10. Licenses, Permits and Miscellaneous Business Regulations – Chapter 10

25-10.1 License fees referenced in Chapter 10, by Article

SECTION 3. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION 4. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.






