**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO OMNI YOUTH SERVICES FOR THE PROVISION OF SOCIAL SERVICES DURING FISCAL YEAR 2024 IN AN AMOUNT NOT TO EXCEED \$39,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois

**WHEREAS**, the Village desires to provide social services for the residents of the community; and

**WHEREAS**, the Village has determined that Omni Youth Services is best able to provide social services to the community; and

**WHEREAS**, the Village has agreed to pay Omni \$39,000 for the provision of social services to the Vernon Hills community; and

**WHEREAS**, funds are available for these payments in the Police Departments Professional Services account (0103031 -520540); and

**WHEREAS**, expenditures over \$25,000 require Board of Trustees approval.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is here by authorized to make payment to Omni Youth Services for the provision of social services during Fiscal Year 2024 in an amount not to exceed \$39,000.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance N umber 2024-009.
